In consideration for being permitted by the City of Frenchburg along with Participating Businesses (Property Owners) and the Frenchburg/Meniffee County Chamber of Commerce (Chamber) to participate in the above activity, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have or which may hereafter accrue as a result of my participation in said activity. This release is intended to discharge, in advance, the Property Owners (its officers, employees, and agents) and the Chamber (its officers, employees, and agents) from and against any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of negligence or carelessness on the part of the Property Owners (its officers, employees or agents) or the Chamber (its officers, employees, and agents).
